
















RECOMMENDED SOLDERING PATTERN (units : mm; tolerance : ± 0.1)











REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS





TAPE SPECIFICATIONS (units : mm)




REEL DIMENSION (units : mm)
