






RECOMMENDED SOLDERING PATTERN






RELATIVE INTENSITY vs. WAVELENGTH




SPATIAL DISTRIBUTION




BLUE



Luminous Intensity vs. Ambient Temperature




REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS






- Don't cause stress to the LEDs while it is exposed to high temperature.

REEL DIMENSION (units : mm)




